In order to be valid, a proxy form and the power of attorney or other authority (if any) under which it is signed, or a notarially certified copy of such power of attorney, must be deposited at the Hong Kong branch share registrar and transfer office of the Company, Hong Kong Registrars Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong, as soon as possible and in event not later than 10:30 a.m. on Tuesday, 7 August 2018 or not less than 48 hours before the time fixed for holding the Meeting or any adjournment thereof.
